Dogs must be crated in your car as there is no inside crating available. There will be a separate area for reactive dog parking. Please look for our ORT parking attendant before parking. All dogs must be ON LEASH at all times, do potty dogs in designated grassy areas. Clean up after your dog, poop bags and trash provided. Be respectful, keep a safe distance from all other dogs and handlers.

All dogs participating in the ORT must be registered with the NACSW™. All handlers must also be members of the NACSW™. Membership and registration are available at: <http://nacsw.net/nacswmembership.html>. Membership and Registration must be completed at least 6 weeks prior to the ORT to allow for processing time.
